TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER 1977-1981

W H E R E A S :-

The Borough Council of Weymouth and Portland (hereinafter called "the Council") being the Local Planning Authority for the Borough of Weymouth and Portland is satisfied that it is expedient that development of the description set out in the First Schedule hereto should not be carried out on land in the Borough of Weymouth and Portland in the County of Dorset specified in the Second Schedule hereto unless permission therefor is granted on application made under the Town and Country Planning Act 1971 on the grounds that the said development would constitute a threat to the amenities of the Area

NOW THEREFORE :-

The Council in pursuance of the powers conferred upon them by Article 4 of the Town and Country Planning General Development Order 1977 HEREBY DIRECT that the permission granted by Article 3 of the said Order shall not apply to development on the land in the Borough of Weymouth and Portland described in the Second Schedule hereto

FIRST SCHEDULE

The use of land described in the Second Schedule hereto (other than a building or curtilage of a building) for the purpose of holding a market (including a Sunday Market) or any like activity including the erection and placing of moveable structures on the land for the purpose of that use on not more than fourteen days in total in any calendar year being development comprised within Class IV(2) as referred to in Schedule 1 to the said Order of 1977 and not being development comprised within any other class

SECOND SCHEDULE

Land situate at Nottingham Lane and Dorchester Road within the Borough of Weymouth and Portland having an area of approximately 2.8 acres at OS 6763 (Sheet Number SY 6682) more particularly delineated and coloured pink on the plan annexed hereto
