

**THE DORSET COUNCIL (OFF-STREET PARKING PLACES) (CONSOLIDATION)
(AMENDMENT NO. 4) ORDER 2025**

Dorset Council, having consulted with the chief officer of Dorset Police in exercise of the powers conferred by the Road Traffic Regulation Act 1984 as amended, the Local Government Act 1985 and the Traffic Management Act 2004 and in compliance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and all other powers so enabling hereby makes the following order:

Part 1: Implementation and citation

1. This Order is made and shall come into operation on 16th June 2025 and may be cited as " The Dorset Council (Off-Street Parking Places) (Consolidation) (Amendment No. 4) Order 2025".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

Part 2: Additions, Revocations and modifications

1. The Dorset Council (Off-Street Parking Places) (Consolidation) Order 2022 is hereby amended to incorporate the following changes:

- a) **PART B: Article 10. Prohibition of sales etc** is modified to the following:

10. Prohibition of Sales etc

10.1 No person shall use a vehicle while it is in a parking place in connection with the sale or hire of any article to persons in or near that parking place, or in connection with the selling or offering for hire of their skills or services, except as authorised by this Order and in accordance with the terms and conditions of the Dorset Council Car Park Sales Licence.

10.2 No person shall sell or hire any article, or offer for hire their skills or services, or those of any other person, in a parking place, except as authorised by this Order and in accordance with the terms and conditions of the Dorset Council Car Park Sales Licence.

b) Amend the following Car Park within Schedule 1 as follows:
