The Ramblers works to help everyone to enjoy the pleasures and benefits of walking, and to enhance and protect the places where people walk. As walkers we understand the importance of our environment for the health and wellbeing of all. We are committed to encouraging and supporting walking, protecting and expanding public rights of way and access land, and protecting the beauty of the countryside and other areas.

The Ramblers welcomes and supports the Vision, Aims and Objectives as set out in the submission version of the Weymouth Neighbourhood Plan. There is much to be applauded and we are pleased to see reference to our Charter in paragraph 8.52.

We have a few suggested amendments on matters of details which we set out below.

In respect of the Environmental Targets (table on page 25), we suggests that the objective for Transport (31) be amended to read "Facilitate sustainable and active transport" so that it covers walking and cycling as well as trains and buses.

In respect of <u>paragraph 8.54</u>, we welcome the statement that "New development should ensure that rights of way are incorporated into the layout whenever possible." However, Defra Rights of Way Circular 1/09 (Guidance for local authorities) is more explicit saying at paragraph 7.8 that "any alternative alignment should avoid the use of estate roads for the purpose wherever possible and preference should be given to the use of made up estate paths through landscaped or open space away from vehicular traffic." We suggest therefore that the statement in paragraph 8.52 should be expanded to cover that point.

With reference to paragraphs <u>8.63. 8.64 and 8.65</u>, the references should be to the England Coast Path (not Coastal). The full name of the path is now the King Charles III England Coast Path.

With reference to <u>Policy W50 (Cycle Routes)</u>, whilst the provision of cycle routes is welcome, it is important that facilities for cyclists are not provided at the expense of facilities for walkers. Walkers are the most vulnerable group of users. Any routes which are to be shared-use (i.e. shared between cyclists and pedestrians) will ideally be at least 3m wide, with 2m an absolute minimum. In determining appropriate widths, is important to take account of local conditions including: expected levels of use, and the different types of walkers and cyclists, the existence of physical constraints, such as hedgerows, fencing/railing and furniture, 'pinch points', the gradient of the route and whether there is to segregation.

With reference to <u>Section 13 (Aspirations)</u>, in the section on Footpaths, it would be preferable to seek to ensure that any new paths are dedicated as public rights of way to secure them for the public in perpetuity and to ensure that they are shown on Ordnance Survey maps. There are a number of different mechanisms by which the status 'public right of way' can be achieved.

With reference to the <u>Glossary (p,200)</u>, we suggest that the definition of public right of way be amended to that used on the Dorset Council website: "A public right of way is a path that anyone has the legal right to use on foot, and sometimes other modes of transport. Public footpaths can be used by walkers, public bridleways can be used by walkers, horseriders and pedal cyclists. Public rights of way are highways in law."
