Objection to the area on Map 22A which is a proposal for industrial development at the end of Weymouth Bay Avenue

I have become aware of the above proposal and have several objections to it

- it is on the edge of a recognised and much respected Bird Sanctuary which attracts people to Weymouth from outside of the immediate area as well as those within the area. An industrial unit is totally alien to the concept of a Nature Reserve.
- Weymouth Bay Avenue is renowned for its peaceful location and any development involving an increase in traffic would be alien to this. The road is not suitable for an increased traffic flow and also would cause more congestion at the junction with Dorchester Road.
- the increase in traffic would involve an increase in pollution which is not conducive to a Nature Reserve or a residential area.
- there is considerable pedestrian use of Weymouth Bay Avenue accessing the nature reserve and this could be hazardous with any increase in traffic especially heavy duty vehicles.
- an increase in vehicles could also lead to an increase in speeding and possible disregard for local pedestrians, many of which are elderly.
- to my understanding there are unused industrial sites at Granby so is there really a need for this proposed development?

Industrial development on the edge of both a nature reserve and a quiet residential area just doesn't make sense especially when a recent Weymouth Neighbourhood Plan flyer which came through the door has one of its headings as the plan 'protects more open spaces'. This proposal would do exactly the opposite.

I trust you will reconsider this part of the Neighbourhood Plan. We have a beautiful town and this proposal, so close to the seafront, is simply wrong.
