

## THE DORSET COUNCIL (OFF-STREET PARKING PLACES) (COUNTY HALL CAR PARK, DORCHESTER) (AMENDMENT NO. 1) ORDER 2025

1. NOTICE IS HEREBY GIVEN that the Council of Dorset has made the above-mentioned Order under the Road Traffic Regulation Act 1984 as amended.
2. When the Order comes into operation on the 16<sup>th</sup> June 2025 the effect will be to introduce the following parking provisions to the rear section of County Hall Car Park, Dorchester:
