



Street works licence under Section 50 of the New Roads and Street Works Act 1991 (NRSWA) | Repair existing apparatus

Applicants not familiar with the requirements of this legislation are strongly advised to appoint a contractor with the appropriate knowledge to help complete this application and to conduct the works on their behalf. Non-compliance with any requirement of the New Roads & Street Works Act 1991 may result in severe financial penalties.



This application is to be used for works which are for repairs to existing apparatus. The minimum notice period for this licence is one month.

Important: repairs to existing apparatus which involve installing any **new** apparatus, cannot be licenced through this application. If new apparatus will be installed during repairs, please complete a licence to install new apparatus.

You can:

We will reject applications if you do not provide the following:

- a fully completed application SWL 3 (this document); and
- a traffic management plan / map this must clearly illustrate the location and extent of excavation works; and
- <u>two</u> valid street works accreditation cards scanned copies front AND back of both, and one MUST show a 'supervisor' designation; and
- a valid insurance certificate minimum £5 million public liability, which covers up to completion of permanent reinstatement

I also acknowledge the statutory need for me to pay the prescribed inspection fee which will be imposed by the Street Authority, including any defect inspection fees and the cost of any necessary remedial works conducted by the Street Authority during the guarantee period.

I also acknowledge that the licence is granted on the condition that I will indemnify the Street Authority against any claim in respect of injury, damage or loss arising out of:

a) the placing or presence in the street of apparatus to which the licence relates, orb) the execution by any person of any works authorised by the licence.

I also acknowledge that I have read and understood the Notes for Guidance and Standard Conditions as attached (NB. Further specific conditions may be imposed at the time of granting the licence).

I confirm that any amendments to the details of the works (including dates of commencement and completion) will be notified to the Street Authority as soon as they are known.
