Notice of an application for the registration of land as a Town or Village Green

To every reputed owner, lessee, tenant or occupier of any part of the land described below, and to all others whom it may concern.

Application has been made to the Registration Authority, Dorset Council, County Hall, Colliton Park, Dorchester, Dorset DT1 1XJ by Diane Gillian Whitfield under section 15(1) of the Commons Act 2006 and in accordance with the Commons (Registration of Town or Village Greens) (Interim Arrangements) (England) Regulations 2007. The application seeks the inclusion in the register of town and village greens of the land described in the Schedule below which is claimed to have qualified for registration as a town or village green based on at least 20 years continuous use prior to the date of the Application on 29th July 2024 by virtue of:

1. The Land has been used by the inhabitants of the locality of the Highland Park housing estate for more than 20 years; and
2. Permission to perform these activities has never been sought or denied.

The application, which includes a plan of the land proposed for registration, may be inspected at the following offices during normal opening hours:


If the registration authority is satisfied that the land described below qualifies for registration as a town or village green, it will so register the land.
