1	<p>Apologies and Declaration of Interest</p> <p>Apologies received: James Weld, Kim Slowe and Rob Dunford</p> <p>Jim Stewart declared an interest in items 3.3 and 5.1.</p> <p>The Board welcomed Gary Suttle and confirmed they were happy to ask him to become a Director of the Dorset Local Enterprise Partnership CIC.</p>	
2	<p>Minutes of Last Meeting and Matters Arising</p> <p>The Minutes were agreed as an accurate reflection of the last meeting and the Action Log was reviewed.</p> <p>Matters Arising:</p> <p>Destination Management Organisation</p> <p>RS updated that the first meeting of the Dorset Tourism Association was taking place on Wednesday 28 September and they were in a good position to start and take things forward.</p>	
3.	FOR DISCUSSION AND/OR DECISION	
3.1	<p>Housing Study</p> <p>Lin Cousins of Three Dragons, on behalf of the wider project team, gave an introduction to the interim housing study work. She explained they were in the process of getting more feedback from employers.</p> <p>AS mentioned she thought it was important that as a LEP Board we collectively address what we want to influence with housing authorities and we need to establish key priorities of what we want to take forward.</p> <p>JSu informed that in North Dorset land owners are invited to put forward land that could be available for housing.</p> <p>JB said that problems are different area to area and town to town. There is land available that developers are not using.</p> <p>GP asked whether the report could include some suggestions as to where it might be appropriate for LEP and LA intervention.</p> <p>Action: LC to speak to Lin Cousins about enhancing the report based on DLEP Board feedback.</p>	LC
3.2	<p>Enterprise Zone (Commercial in Confidence)</p> <p>LC introduced the implementation plan funding request. The Board was asked to release funds to enable the implementation plan to be started which would be finalised by 31 March 2017.</p> <p>Action: All agreed they were happy to release the funds to enable the implementation plan to be completed subject to agreement with the collecting authority that this would be reimbursed.</p>	All Agreed

3.2	<p>Enterprise Zone Cont'd</p> <p>Having a local development order in place was also discussed. The Board agreed that it is necessary to have this in place as it is a good addition to the site and would make it easier for businesses moving in by providing more certainty and speed of process</p> <p>If the LEP were to fund it the question was asked about how the loan would be re-paid. LC confirmed this could be through the business rate retention from the businesses on the site. RS mentioned he would be less comfortable if core funding was used to fund this.</p> <p>Action: All agreed for LC to explore how best to get a local development order in place.</p> <p>BD explained that they have a lot of information they can provide to the Board.</p> <p>Action: LC to follow up with BD.</p> <p>LC then introduced the Acquisition of the Site paper. She explained a Red book appraisal had been commissioned but was not available until 14 October. The options proposed were all subject to a full business case and understanding the financial options from the accountable body. The Board was asked whether they wanted the LEP team to carry on gathering more information for the November Board meeting.</p> <p>A discussion took place over the purchase of the land. It was mentioned that due diligence must be completed. It was agreed that it would be better if the land was under public ownership. It was stated that the LEP have been awarded the Enterprise Zone status and we all need to make it work. The owner needs to be the right person and someone who wants to make the site a success for Dorset.</p> <p>AS explained that you have got to use some risk money to find out all the answers.</p> <p>Action: LC to see if there are examples of where other LEPs have acquired land.</p> <p>Action: LC to organise a meeting with Dorset County Council and Purbeck DC once the Red book appraisal had been completed.</p> <p>YE informed that Ministers were considering a commercial package of help in regards the Enterprise Zones.</p> <p>Mineral and Waste Planning Update</p> <p>LC updated the Board on the proposed Waste site proposal near Bournemouth Airport. LC has raised the LEP's concerns with Dorset County Council's planning department, the land owner and developer.</p> <p>GSu fed back that Christchurch Council have said that no-one has consulted with them.
