Policy 33 - Occupational Dwellings in the Countryside

10.247 - Para 55 of the NPPF directs that occupational dwellings can serve "rural workers" this policy only allows temporary dwellings for agricultural business', the opportunity to apply for a temporary dwelling should also be available to forestry and other rural business'.

Policy 29- Reuse of existing buildings in the countryside

10.169- Para 28 of the NPPF states that the Local Plan should support the rural economy "through [the] conversion of existing buildings", NDDC state that they will not support the retention and reuse of agricultural buildings over 500m²; this is not in line with para 28. There is no logical reason for this artificial restriction and each case should be taken on it's own merits.

A large number of both traditional and modern farm buildings are over 500m² in size and there should be no restriction on alternative economically viable uses.
