I believe that paragraph 2 of policy 4 (locally designated sites section) is **unsound** because it is not **consistent with national policy**. I believe this section is not consistent with the NPPF because there is no mention of enhancing locally designated sites where opportunities exist to do this. The NPPF is quite clear that enhancements should be considered as part of the planning process, for example;

- Paragraph 109 of the NPPF requires the planning system to contribute to the natural and local environment by “Minimising impacts on biodiversity and providing net gains in biodiversity where possible”.
- Paragraph 114 states that “Local Planning Authorities should: set out a strategic approach in their local plans, planning positively for the creation, protection, enhancement and management of networks of biodiversity and green infrastructure.

I recommend that wording is added to this part of policy 4, that encourages applicants to consider if their proposals could enhance sites rather than just mitigate any adverse impacts.

Suggested text is recommended below;

As a last resort, compensation measures may be acceptable if effective mitigation cannot be provided prevent residual biodiversity loss. Such compensation measures must offer gains equivalent in magnitude to the loss resulting from the development. Where possible, proposals should seek to enhance the biodiversity value of sites.
