North Dorset Local Plan – 2011 to 2026 Part 1

Pre-submission Consultation 29 November 2013 to 24 January 2014

We are writing to let you know that the North Dorset Local Plan – 2011 to 2026 Part 1: Pre-submission Document (Local Plan Part 1) was approved by Members at Full Council on 27

September 2013 for publication prior to its submission to the Secretary of State for independent examination.

The 15 year plan, formerly known as The New Plan for North Dorset (or Draft Core Strategy) identifies key locations in the District for the growth of housing and jobs until 2026. It sets out the strategic planning policies for the District that will guide the development of 4,200 new homes together with associated employment land, community facilities and infrastructure.

This pre-submission publication version of the Local Plan Part 1 builds on previous consultation stages in 2010 and 2012 where the views of local communities on the content and strategy of the plan were sought. Based on the comments received at these earlier stages, North Dorset District Council has finalised a plan that it considers to be 'sound'.

The pre-submission consultation period starts on **29 November 2013**. Further information on the consultation and how to make a representation can be found on the enclosed **Statement of Representations Procedure**. A statement setting out the arrangements to view the Local Plan Pre-submission Document and other proposed submission documents is also enclosed.

The **deadline** for representations is **5pm on 24 January 2014**. Only those who have submitted their representations within the consultation period have the right to have their comments sent to the Secretary of State and subsequently considered by an Inspector at examination.
