OBJECTION - Policy 2: Core Spatial Strategy.

Cawdor Construction Ltd wishes to object to Policy 2: Core Spatial Strategy, and the removal of the Settlement Boundaries from all the villages across the District. We think this would be a very unsound proposal.

The implementation of the Policy would stop virtually all development within the villages, leaving them stagnant, and more vulnerable to the loss of further services and amenities. It would reduce employment opportunities across the District for everyone employed in the construction industry. Many people don't want to live in the towns, they like village life and enjoy living in smaller communities in the countryside. It's not right to dictate that anyone who wants a new, energy efficient home must live in a town.

Imagine if all authorities across the country adopted such a proposal. Nothing would get built. With proposals like this, it's little wonder we don't build enough houses in this country.
