UN SOUND: Conflict WITH NPPF: (PARA'S 48 - 55.)
 The proposed abolition of all village/settlement boundaries, which consequently prevents any new homes being built (other than affordable - exception sites), is extremely unfettered. Modest, well designed housing, with good access & no impact upon neighbours, which enables new families & others to remain or live in a village, would add to the 'vitality' & 'vibrancy' of the village and perhaps most importantly would ensure the village services (shop - post office, church, Public House, School, etc) remain open.

Retention of village boundaries, to stimulate modest and controlled housing growth, would ensure villages (and their vital community services) survive. This policy has succeeded with NDDC's old Local Plan for almost 15 years on this basis, whilst trying to force Parish Councils to develop their own N.P.'s is the wrong approach. Many P.C.'s don't have the time or resources to write N.P.'s, and the retention of boundaries would enable NDDC & P.C.'s to ~~improve~~
