Persimmon Homes South West object to the proposed change CON/6/4 i.e. the revision of the housing provision set out in Figure 5.1. An objection is made to the consequential change to the district housing provision. The revised housing provision does not reflect the objectively assessed housing need for the district. Instead it demonstrates that the housing provision in the plan can be amended to suite the yield of an individual site.
