Persimmon Homes South West has already submitted objections to the Pre-Submission Plan in respect of the soundness of the plan in relation to the plan period and the housing requirement and the deliverability of the urban extension to Gillingham.

Non- Technical Summary of the Supplement to the Pre-Submission Sustainability Appraisal Report

Persimmon Homes South West note that new information has come available since the Local Plan Pre-Submission version was prepared. It is a concern that this is fundamental information from a statutory consultee which has come to light very late in the preparation of the plan. It appears that this information is so important to the Plan as the impact of development at Crown Meadows was considered to be so significant that development should not take place due to the severity of the impact. Paragraph 1.6 states that this necessitated a review of options for accommodating the growth of the town.

It is noted that further information has also become available for the site to the south of the A350/A354 roundabout as part of the pre-application process and that analysis of this information has concluded that the impact of the site will be less than previously thought.
