**Policy 16: Blandford**

This Policy should be stronger on supporting the town centre shops in Blandford, especially in view of new Asda and extended Tesco, which greatly increase the amount of out of town shopping. See also Policy 12.

The CPRE **strongly opposes** development on the Crown Meadows, euphemistically referred to as the West of Blandford development.

A development here would seriously damage the important contribution that the Meadows make to the setting of Blandford and would be contrary to the statement in Policy 16, that Blandford's distinctive natural and historic character will be retained and enhanced. It is also contrary to the provisions in NPPF Section 12: Conserving & enhancing the historic environment.

This proposal has been opposed by thousands of Blandford residents.
