Transport – Gillingham

Gillingham is to be the major centre for housing and commercial development in North Dorset. Without improvements to the rail network, especially restoring dual tracks on the main line to London, the envisaged economic and social growth will not be achieved. A policy should be included to work towards this with appropriate organisations.

As recent flooding events demonstrate, the policy on flooding is important. The policy commitment on flood prevention is unclear and vague. It should be strengthened. Dorset County Council also now have a responsibility to deal with flooding as well as the EA.

The Council will also work with these bodies to deal with the transfer and treatment of wastewater and the introduction of sustainable drainage systems. Sustainable drainage solutions appropriate to the development and underlying ground conditions should be incorporated into all new developments of two dwellings or more and connect with the overall surface water management approach for the area.
