I FEEL THE LOCAL PLAN HAS NOT TAKEN INTO ACCOUNT THE DAMAGE IT WILL DO TO BLANDFORD. OVER 6,000 RESIDENTS SIGNED A PETITION (OVER 60% OF ADULT POPULATION) AGAINST BUILDING ON THE CROWN MEADOWS. THE PLANNERS HAVE IGNORED THE STRONG FEELING OF LOCAL PEOPLE. THE CORE STRATEGY WHICH IS STILL IS RELEVANT STATES (BL7) CROWN MEADOWS SHOULD BE PROTECTED FROM ANY ENCROACHMENT OF DEVELOPMENT. WHAT HAS CHANGED, ITS AS IF THE CROWN MEADOWS SHOULD BE SACRIFICED FOR A SMALL AMOUNT OF MONEY FOR THE CROWN ESTATE. THE PEOPLE OF BLANDFORD ARE NOT HAPPY WITH THIS.

Policy 16 CROWN MEADOWS, THEY ARE A VERY IMPORTANT PART OF BLANDFORDS HISTORY + PRESENT DAY, IMPORTANT ASSET FOR LOCAL PEOPLE + TOURISTS, THE LOCATION, OTTERS AND PROTECTED GREATER HORSESHOE BATS WHICH ARE PROTECTED THEY ARE RESIDENTS OF BRYANSTON SCHOOL & USE THE CROWN MEADOWS TO FEED ON. IF MOVED, THE SITE WILL NEED 20 YEARS TO BE PREPARED FOR THE FEEDING OFF COCKCHAFFER BEETLES TO MAINTAIN THE BATS. THE SITE FLOODS REGULARLY AND NOT SUITABLE FOR HOUSING. THE TRAFFIC IS VERY BAD A CONTINUOUS CONGESTED STREAM OF TRAFFIC EVERY DAY, THIS DEVELOPMENT WOULD ADD TO THIS. THE SITE AT ST MARY HILLS IS IDEAL, AS IT HAS GOOD ACCESS TO BLANDFORD TOWN CENTRE, AND IS LAND WHICH HAS NO WILD LIFE OR ANY OTHER IMPORTANCE UNLIKE CROWN MEADOWS
