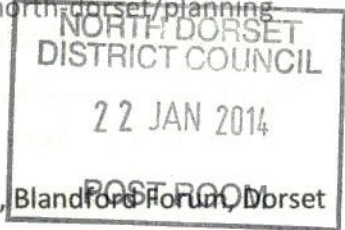

Development of the Crown Meadows is unacceptable:

The proposals are contrary to the wishes of the majority of the local residents, and visitors to the town, and is unnecessary whilst there is a viable alternative site at St Mary's Hill.

The site is a Conservation Sub-area and an AONB. It is unimproved meadowland and the feeding ground of the endangered greater horseshoe bat.

It is of historic importance, owing to the association with the Portman family and the World War anti tank defences. It would damage the rural setting of the town.

Development of the Crown Meadows would result in a significant increase in the traffic flow and result in further congestion in the town centre. The congestion is already excessive and unacceptable.

Paragraph 8.24 should be amended to omit mention of land to the west of Blandford Forum
