Objection is raised to both paragraph 4.105 and consequently Policy 4 and so both are addressed together here in this representation.

There is no objection, in principle, to the fact that forthcoming Neighbourhood Plans should consider the designation of Local Green Spaces. However, the term Local Green Space does not even appear with Policy 4 – there is reference to Local Designated Natural Environment Sites but this would appear to relate to sites of nature conservation importance.

It is fundamentally wrong and inappropriate to try to introduce policy through supporting text.

It is not clear whether Local Green Spaces are intended to replace the Important Open/Wooded Areas within settlements (IOWAs) which are addressed by Policy 1.9 of the existing Local Plan. It is indicated under the Schedule of Policies to be retained that this policy is intended to be retained and reconsidered through the next stage of the Local Plan/Neighbourhood Plans. Whilst this may be the correct approach to the detailed designations, it adds further ambiguity as there is no reference to IOWAs or their replacement in Policy 4 and therefore no overarching policy for their continued existence in the Local Plan Part 1.

Moreover the Inspector at the previous Local Plan examination questioned the appropriateness of this designation and invited the Council to reappraise the policy and the designations but this has not yet been undertaken. If IOWAs are to be carried forward into the new Local plan strategy there should be an explicit commitment to their review at the appropriate stage.

These representations also cross refer to Policy 15: Green infrastructure and its supporting text.
