Hall & Woodhouse support the identification of Sturminster Newton as one of the main towns within the District where development is to be directed.

However, the Sustainable Development Strategy should prioritise that development and redevelopment will first be directed to within the existing settlement area, before necessitating small scale green field extensions to the settlement boundary.

Consequently statement e) under Meeting Housing Needs should provide for infilling, development and redevelopment within the settlement boundary to ensure that all opportunities within the existing settlement boundary are prioritised.

This approach would safeguard countryside beyond the existing settlement boundaries and ensure that priority is given to strengthening the existing settlement within its defined boundary.

The proposed amendments would ensure that the policy was justified and effective and in accordance with national guidance.
