There is no direct access to the Blandford bypass. I have attended public consultations on these matters and the answers I have been given have been evasive, shown a lack of knowledge of the site or been clearly disingenuous. I note that there are no Proposed housing nos: on your plan. Is this not a legal requirement? I have enclosed photographs (of proposed access roads) which appear to have been neglected in your plan

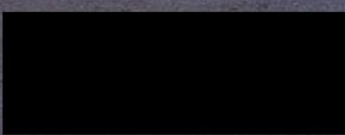

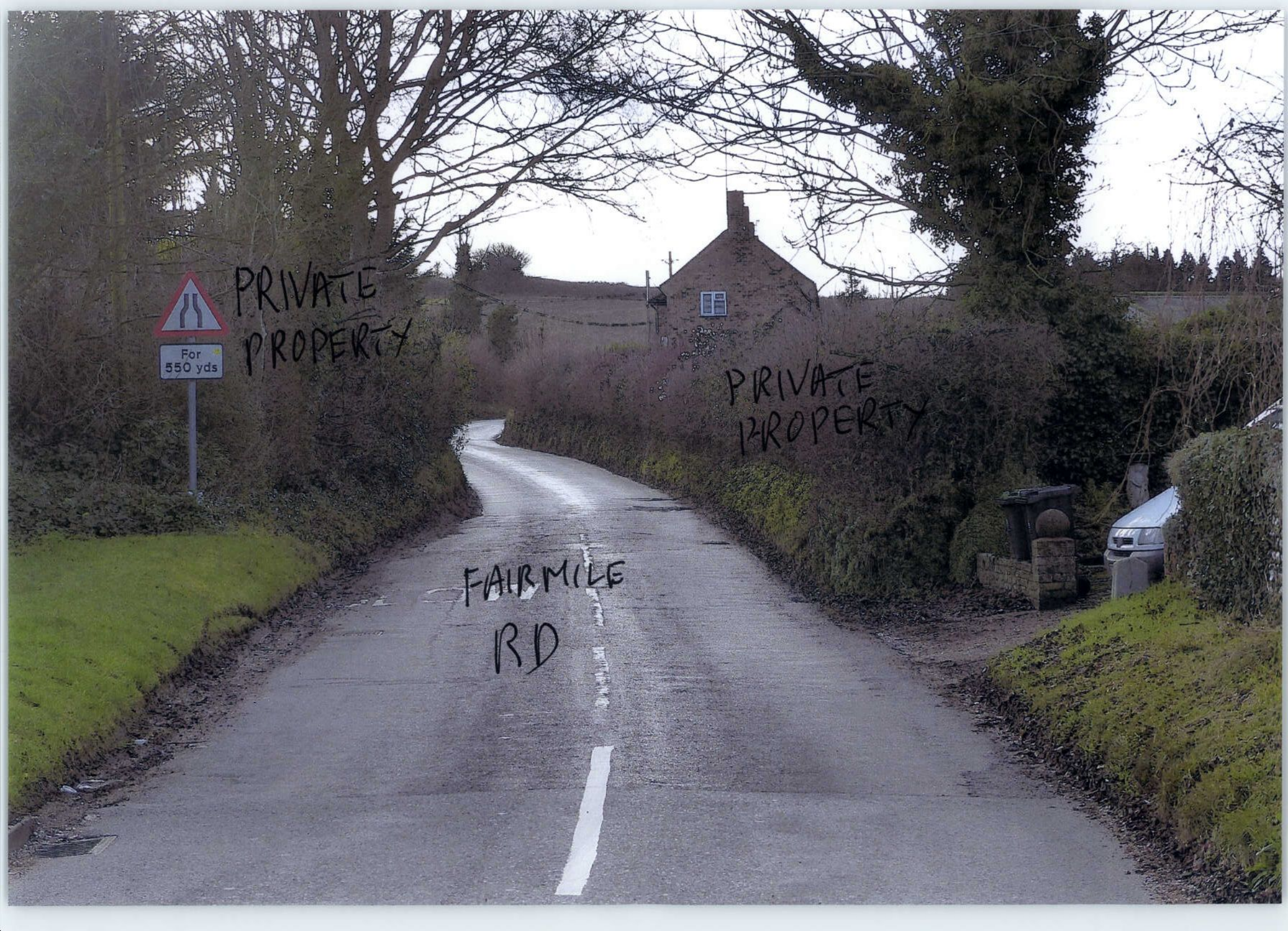
