Policy 31 and the preceding text is too restrictive. It advises that new built tourist accommodation in the countryside will only be permitted if reusing an existing building in line with policy 29. This runs counter to Part 3 of the NPPF and would preclude, for instance, the erection of certain types of chalet or other new build accommodation that may be acceptable and in compliance with National Policy.

Sub-section (a) is overly restrictive restricting tourist accommodation to those locations which can be accessed by means other than the car. This is entirely inappropriate within a wholly rural area and would severely curtail the potential for tourist accommodation in the countryside. It should be noted that para 29 of the NPPF recognises that opportunities to maximise sustainable transport solutions will vary from urban to rural areas. The NPPF is extremely supportive of all forms of sustainable growth and expansion of business and enterprise in the countryside both through conversion of existing buildings and well designed new buildings.

At (b) it is suggested that the only forms of farm diversification permissible will be small in scale – this runs counter to advice in Part 3 of the NPPF.
