Statement of Modifications to the Purbeck District Council Community Infrastructure Levy Draft Charging Schedule Regulation 19 (1)(d)

1. The Purbeck District Council Community Infrastructure Levy (CIL) Draft Charging Schedule was published for public consultation between 22nd October and 3rd December 2017 in accordance with Regulation 16 of the CIL Regulations 2010 (as amended). The Council is submitting its Charging Schedule for Examination on **28 January 2019**. On this date, a Statement of Modifications to the CIL Draft Charging Schedule is also being published. This Statement of Modifications sets out the modifications which Purbeck District Council has made to its Draft Charging Schedule since it was published for consultation. The Council considers the modifications to be minor, clarifying existing information or explaining the process once the schedule is agreed.
2. A copy of this Statement of Modifications has been sent to consultation bodies that were invited to make representations under Regulation 15, and is published on the Council website, and will be available with the submission documents.
3. Anyone wishing to comment on the statement of modifications may ask to be heard by the examiner, within four weeks of the Statement of Modifications being published and the Charging Schedule being submitted to the examiner. Anyone wishing to be heard should give details where appropriate; for example, whether they support or oppose the modification and why.
