Paragraph 7.138 of the Local Plan requires outdoor sports and play space to be provided in line with the Fields in Trust Standards. Whilst there is no fundamental objection to this approach, the Fields in Trust set out differing standards for urban and rural locations. The Local Plan does not make it clear which should be applied in North Dorset.

For example, it is understood that the district as a whole is identified as being rural. However, the towns of Blandford and Gillingham have sufficient populations to be classified as urban. It is therefore unclear as to which of the Fields in Trust targets for the provision of outdoor sport and play space should be applied.
