Paragraph 4.64 states that the Council will seek advice on landscape impact from the AONB management teams. However, a landscape appraisal of land at Blandford St. Mary has already been undertaken by Dorset County Council as part of the background evidence to inform the Local Plan. Titled "*Landscape Impact Assessment of Potential Housing Sites in Blandford and Shaftesbury*", this was part of a district wide study so as to establish a consistent approach for all of the major development sites as proposed within the Local Plan. The impact on the AONB has therefore already been informed by this exercise.

A planning application for the development of land at Blandford St. Mary will be accompanied by a more detailed landscape assessment. Future consultations on the development proposals should only deal with the effectiveness of the landscape strategy for the site, and should not re-visit the evidence base that has already been used to confirm the development allocation.
