Paragraph 7.139 is unclear as to its intention; and is confusing. It refers to an ambition to achieve one allotment plot for every 60 people in a settlement, and then appears to link this to sites where development is proposed. This implies that development sites will be required to take up any shortfall that may exist within any particular settlement.

There may be some development sites where it is wholly inappropriate, in terms of visual amenity, to provide allotments. In these instances it would be more appropriate for finance to be made available for the provision of allotments off site as part of a community infrastructure package.
