Paragraph 8.12 of the Local Plan seeks to defer the development of greenfield sites until all existing allocated sites, and those with planning permission, have been built out. This approach is not sound; and is not in accordance with the NPPF.

There is no guarantee that all existing sites will come forward for development immediately. Some may be delayed, whilst others may not be developed at all. Under these scenarios, new greenfield development would also be unnecessarily delayed. Given that the Local Plan, and its development allocations, is considered to meet sustainability objectives, there is no reason to defer any sustainable development that can be constructed pursuant to its policies.

The NPPF, at Paragraph 15, requires development that is sustainable to be approved without delay. Paragraph 17 stresses the need to deliver homes; and Paragraph 47 requires local planning authorities to significantly boost the supply of housing. Paragraph 8.12 of the Local Plan arbitrarily introduces phasing that will have the opposite effect of what the NPPF is setting out to achieve.
